



## Terms of reference Consultants- Push Button Replication 3ie, New Delhi

### 1. Background

[The International Initiative for Impact Evaluation \(3ie\)](#) promotes evidence-informed equitable, inclusive and sustainable development. We support the generation and effective use of high-quality evidence to inform decision-making and improve the lives of people living in poverty in low- and middle-income countries. We provide guidance and support to produce, synthesise and quality-assure evidence of what works, for whom, how, why and at what cost. 3ie is registered as a non-governmental organisation in the United States. It has offices in New Delhi, London and Washington, DC.

A part of our commitment to [research transparency](#), we conduct push button replication (PBR) to verify the results reported in our publications using the original data and code submitted by researchers. The purpose of this project to verify the results from 3ie-funded studies to make the data, code and all other replication materials reusable.

3ie is looking for consultants to support our ongoing verification project. The consultant will be based out of 3ie's New Delhi office.

### 2. Key responsibilities

3ie will recruit one consultant for each grant. S/he will be responsible for the tasks listed below.

- Provide feedback on the verification of data and code to help assure replicability and reusability of the same;
- Make recommendations to improve reproducibility;
- Conduct thorough checks of the code and data to ensure that false results are not published; and
- We estimate this can take around four days total spread over 6 months.

### 3. Qualifications and skills

- Graduate or pursuing Master's degree in social sciences or related fields;
- Experience in using statistical software (such as R, SPSS, Stata) is required; and
- Prior knowledge of replication or experience in conducting replication research is desirable.

## 5. Indicative level of review work

- Data and code will be reviewed with either the last round of deliverables or with the last two rounds of deliverables for a particular grant;
- We anticipate up to two or three reviews per delivery round (up to six reviews in total); and
- It can take up to two days for each round.

## 6. Terms of employment

**The consultant will report to a research associate and a senior evaluation specialist. The consultant will work from 3ie's New Delhi office, using only 3ie provided equipment or space. This is a part-time position. The consultant will be paid a fixed fee** for each round upon submission of PBR reporting template, a research log, replicated outputs and automated replication files. For minor follow-ups (i.e. the number of reviews in a round), no additional payment will be made.

The application package must include the following:

- A cover letter, not exceeding one page, highlighting your experience relevant to the terms of reference. A summary on your CV is not a substitute.
- Curriculum vitae (not to exceed two pages);
- Name and contact information for (two) references who can speak for your software skills; and
- One sample code/log file (in a software of your choice) to demonstrate your experience in the field.

Incomplete submissions will not be considered. Only those shortlisted will be contacted Applications must be submitted by **23:59 hours IST, 15 February 2019**. Applications will be accepted until the positions are filled.
