



## Quarterly Report October – December 2016

### Delhi Evidence Week 2016

3ie held its second successful Delhi Evidence Week 2016 in November. Michael Woolcock, lead social development specialist at the World Bank, delivered the opening public lecture on finding more effective ways to use evaluation to assess the internal and external validity of complex interventions. He stressed that impact evaluation methods are often inadequate to address the complexities of local contexts, especially in sanitation.



3ie and the Water Supply and Sanitation Collaborative Council kicked off a co-hosted a one-day conference on *Sanitation for all* after Woodcock's lecture. It featured four sessions on how high-quality research evidence can be used to address challenges in the water, sanitation and hygiene (WASH) sector in India. These sessions were well-attended and included several prominent personalities in the WASH sector in India.

Education was the focus of the second day of 3ie's public events. The sessions started with the launch of 3ie's education effectiveness review to a packed audience. A panel of Indian experts then analysed the importance of better evidence to improve education in India. Atishi Marlena, advisor to the deputy chief minister of Delhi, spoke about the challenges facing the government in implementing major education reforms. "Even if evidence exists on the effectiveness of an education intervention, systems need to be in place for implementing it". ### Evidence uptake and use from 3ie-funded studies

**Using findings from an impact evaluation in Mexico to inform a pilot agricultural extension programme in Kenya:** While Mexico has several programmes to improve farm productivity, such as loan programmes, subsidies for technical assistance and inputs, and extension worker programmes, none of them has been subjected to rigorous evaluation. A new impact evaluation assessed the impact of two programmes, the *Technological Guarantee Programme* and the *Extension Agent and Soil Analysis Programme*. They were implemented in the Mexican state of Tlaxcala and targeted small rain-fed farms with low levels of technological adoption.

The Feed the Future Innovation Lab for Assets and Market Access (also known as BASIS) identifies and supports innovative agricultural economic research around the globe and promotes those projects that empower the vulnerable to sustainably rise up out of poverty. The research team engaged extensively with the director of the BASIS Assets and Market Access Collaborative Research Support Program. He has shown keen interest in the study results from Mexico and plans to disseminate the findings to policymakers in the US and globally. He has also expressed willingness to provide financial support for a pilot agricultural extension service programme in western Kenya. It will implement the model evaluated in Mexico, which will be adapted to fit the context of western Kenya. An impact evaluation will be conducted of the Kenyan pilot, which will help build the evidence base on the effectiveness of providing soil analysis information and on the adoption of locally appropriate agricultural inputs.

## Registry for International Development Impact Evaluations (RIDIE), Impact Evaluation Repository and 3ie Expert Roster

**RIDIE:** The [registry](#) had 99 registrations at the end of fourth quarter. 3ie ended its contract with RAND and took full control of updating and maintaining the database until it can be transferred to the Centre for Open Science.

## Bursaries

3ie funded 13 evaluators to attend impact evaluation training between October and December. Participants from Africa, Asia and Latin America attended a variety of workshops focusing on policy uptake and methods. 3ie funded participants to attend the Cochrane Colloquium in Seoul; the Asia-Pacific Evaluation Association conference in Hanoi and the Evidence in Governance and Politics workshops in Connecticut. Additionally, participants attended three separate impact evaluation trainings in the UK organised by Crown Agents, Public Administration International and the London International Development Centre, respectively.

### New funding

- Population Foundation of India signed a professional service contract with 3ie for USD8,000 to ensure the quality of the impact evaluation of its education entertainment intervention, *Main Kuch Bhi Kar Sakti Hoon* (I, a woman, can achieve anything).
- The William and Flora Hewlett Foundation has awarded 3ie USD6,000,000 over three years for general operating support.
- UNICEF added USD10,944 to its funding for the evaluation of the regional adolescents' programme in Afghanistan, India and Pakistan run by UNICEF and IKEA Foundation. The total funding is now USD1,946,883

### 3ie finance update

As of 31 December 2016 statements\*, 3ie's assets stood at USD82.77 million, including USD38.25 million held in bank accounts, USD44.10 million as grants receivable, i.e. undisbursed balances in signed grant agreements, USD0.42 million in other receivables, fixed assets and deposits and the accrued liabilities for expense and grants payables at USD1.96 million. Total expenses in the quarter were USD8.27 million, of which USD6.49 million were grant expenses.

\*These numbers are provisional. 3ie is in the process of closing the financial year audit. The final figures will be mentioned in the 3ie annual report 2016.
