Membership benefits

- **Participate in 3ie's community of practice for evidence-informed decision-making.** We organise an annual 3ie members' conference, where participants share their experiences producing and using evidence to inform decision-making, discuss their membership priorities and contribute to 3ie's strategic agenda.
- **Help set 3ie's strategic priorities.** Members play a key role in 3ie's governance, electing board commissioners and discussing our strategic direction.
- **Commission a variety of 3ie services.** Members may avail themselves of any of our fee-based services, including having us produce and/or assure the quality of impact evaluations, systematic reviews or evidence gap maps. You can also commission tailored capacity development workshops or co-organise joint events.
- **Promote your work through 3ie's network.** We will advertise your events, jobs and calls for funding through our website and bimonthly newsletter.
- **Be eligible for 3ie bursaries.** Members have priority in receiving support to participate in selected training sessions or other events.
