Evidence uptake and use from 3ie-funded studies



3ie-supported evaluation informs USAID education projects in South Africa

The United States Agency for International Development (USAID) is using the findings of a 3ie-funded evaluation to support follow-up evaluations to improve reading skills in South Africa. 3ie funded the evaluation of the early grade reading study (EGRS), which compared the effectiveness of three approaches to improve Setswana-language reading outcomes of grade one and two students in two districts of North West Province.

After consultations with the evaluators, USAID funded EGRS II, to evaluate alternative ways to impart teacher coaching for effective teaching of English as First Additional Language in Mpumalanga Province. USAID also reconfigured its Reading Support Project to extend EGRS implementation and evaluation to grade three in the North West Province. Read the brief.

3ie led a **capacity development training** in Dakar, Senegal from 10–12 December. The training was organised by the Ministry of the Economy, Planning, and Cooperation, though the Office of Planning and Economic Policies, and was attended by 40 participants invited by the Ministry for their public policy and evaluation work. Through WACIE, 3ie has also signed a partnership MOU with CLEAR-FA to collaborate on future trainings and initiatives in the francophone region.

3ie at the What Works Global Summit

3ie staff actively participated in panel sessions and made presentations on a range of topics at the What Works Global Summit 2019 held in Mexico City from 14–18 October. We organised well-attended pre-conference workshops on topics like designing and using policy briefs; strategic communication; rapid response and systematic reviews; and promoting, monitoring and reporting on evidence use.



Our staff presented the latest evidence gap map on peacebuilding; a synthesis and map on transparency and accountability in natural resource governance; and two major systematic reviews on payment for environmental services and citizen engagement in public services through participation, inclusion, transparency and accountability. We also had several interesting panel discussions with experts on funding research for policy impact, taking stock of systematic reviews in international

development, and curating, translating and integrating evaluation evidence into policymaking. Around 500 world leaders in evidence-informed decision-making, including researchers, evaluators, policymakers, funders and students, participated in the conference. Registry for International Development Impact Evaluations and the Impact Evaluation and Systematic Reviews Repositories

Registrations in the Registry for International Development Impact Evaluations increased from 181 to 190 in the last quarter. The Impact Evaluation Repository has a total of 4,802 records. The Systematic Review Repository now has 691 records.

Bursaries

3ie awarded 17 bursaries of which 65 per cent were given to women applicants. The bursary awards were provided for What Works Global Summit held in Mexico and an impact evaluation course organised by LIDC in London. The awardees belonged to Sub-Saharan Africa, East Asia and Pacific and Latin America and the Caribbean.

Membership

The Sustainable Development Policy Institute, Pakistan, has joined 3ie as a new member. We also renewed our MOU with Population Foundation, India.

New funding

- We have received a grant of GBP 105,055 from the German Institute for Development Evaluation (DEval) to provide services that facilitate access to rigorous development evidence for decision-making for the Rigorous Impact Evaluation project.
- Asian Development Bank has signed a consultancy contract with 3ie for USD 137,153 for

- a systematic review on the impact of access to electricity on household welfare.
- African Development Bank signed a consultancy contract with 3ie for USD 30,000 for peer-review services of three project impact evaluations (irrigation, transport, energy) and evaluation of their self-evaluation systems.
- The Department of Foreign Affairs and Trade, Australia, has awarded AUD 1,000,000 for the second phase of Philippine Evidence Programme (formerly Philippines Policy Window).

3ie finances

As of 31 December 2019, 3ie's assets stood at USD 52.58 million, including USD 35.91 million held in bank and investment accounts, USD 16.37 million as grants receivable, i.e. undisbursed balances in signed grant agreements, USD 0.30 million in other receivables, fixed assets and deposits, and the accrued liabilities for expense and grants payables at USD 1.07 million. Total expenses in the quarter were USD 3.08 million, of which USD 0.64 million were grant expenses
